Subject: Submission of Annual 2010 Internal Examination (IHC, Env.St., S &C, Comp. Skills, French viva voce, CBT etc.) and Practical Award Lists

Principals of Degree Colleges under the jurisdiction of Osmania University are hereby ADVISED to ensure that **Internal Examination IHC, Env.St., S&C, Comp. Skills, French viva voce, CBT etc.) and Practical Award Lists** of Annual 2010 Examinations MUST be submitted to this Examination Branch by 5.00 PM (1700 hours IST) on the dates specified in the Practicals Time Table (No. 251/ UG./YWS/Exams/2009- 2010.) notified and issued on 28-01-2010.

Award Lists submitted **AFTER** the specified time-frame **will not be accepted** by this examination branch **under any circumstances**.

This position will not be relaxed for any reasons whatsoever since acceptance of late submissions even with considerable penal fees is being viewed by colleges, with a sense of complacency.

This practice adversely affects both the accuracy and the schedule of result-processing leading to serious problems which are extremely difficult to handle on such a large scale.

Hence **ALL Principals** of Degree Colleges are **requested to extend highest priority to this issue and to cooperate fully with the Examination Branch** in the interests of the Students of their respective colleges.
