The Notification cited refers to <u>**Two Play Grounds located at deferent places as detailed**</u> <u>**below**</u>. The lessee of the Play Grounds should use the Play Grounds for playing purpose only. The Play Grounds shall be given on lease for a period of (2) two years to those who offer highest lease amount to utilize the Ply Grounds for playing purpose. In case of a tie, the Ground shall be put for open auction as explained under terms and conditions of lease.

The minimum bid amount for two (2) years shall be as detailed above. The EMD of Successful bidder will be kept as security deposit which may refunded at the end of contract period duly deducting the dues if any.

It may be noted that applicant shall have to submit a declaration in writing along with his application stating that he is ready with the amount as per his bid offered, and the same will be deposited within 3 working days if they declared as successful bidder.

Application form completed in all respects duly signed together with Demand Drafts drawn in favor of Registrar, Osmania University towards EMD in a sealed cover addressed to the Registrar, Osmania University, Hyderabad - 500 007 may be dropped in the tender box kept in the Estate Cell not

later than **3.00 P.M. of 10.07.2023.** To maintain the fair and transparency in tender process all the applications and interested persons are invited to be present at the time of opening of tenders. The sealed covers will be opened at **4.00 P.M. on 10.07.2023** in the presence of applicants who ever present in Committee Room, Registrar's Office, Administrative Building, O.U. It may be noted that the successful bidder has to deposit entire lease amount within 3 days. If the successful tenderer fails to turn up within 3 working days his EMD will be forfeited and the next highest bidder will be given a chance.
