- Affiliation Rishi College of Education, Bairagiguda, R.R.Dist. Surprise visit Sub: of Inspection Committee - Certain irregularities observed - Violation of NCTE/University norms - Issue of Disaffiliation Orders from the academic year 2018-19 – Resolution of Executive Council - Reg.

The University, based on the several complaints received regarding nonfunctioning of Rishi College of Education, Bairariguda, R.R.Dist. at the premises sanctioned by the NCTE/University, has conducted surprise inspection of college on 16-09-2017. The Committee which visited the premises has observed the following irregularities :

- 1. The college name board Rishi College of Education is not displayed on the building. 2. In the same premises, a school, by name Rishi Public School, is running and its name board Rishi Public School is displayed.
- 3. None of the teaching staff including Principal are available.
- 4. Laboratories, Library required for running the B.Ed College are not available. 5. It is evident that Rishi College of Education is not functioning in the premises where NCTE/University has sanctioned the college.
- 6. The School Prinicpal Ms.Kusuma was present and informed that B.Ed classes are not

Based on the above irregularities observed by the Committee, a Show Cause Notice dt.25-09-2017 was issued to the Management of the college, calling for explanation for the

Subsequently, the Management of Rishi College of Education has submitted their explanation through their letter 2nd cited. Further, the University has constituted a Committee to examine the explanation submitted by the college and suggest further course of action.

Accordingly, the Committee constituted has met on 17-01-2018 and after thorough examination of the explanation submitted by the Management of Rishi College of Education for each irregularity pointed out by the University Inspection Committee has concluded that Rishi College of Education is not existing in the sanctioned premises and college is existing only on paper as there is clear evidence that Rishi Public School is functioning in the Rishi College of Education premises which is a gross violation of Osmania University norms and NCTE Regulations, 2014. The Committee further opined that through the explanation submitted, the Management of the college has tried to mislead the University by submitting wrong, false and malicious information and therefore recommended for disaffiliation of Rishi College of Education, Bairagiguda, R.R.Dist. (College Code : 2499) from the academic year 2018-19.

The recommendations of the Committee for disaffiliation of **Rishi College of Education**, **Bairagidua**, **R.R.Dist. from the academic year 2018-19** were submitted to the Standing Committee of the Academic Senate for its approval. The Standing Committee of the Academic Senate for its approval. The Standing Committee of the Academic Senate at its meeting held on 22-02-2018 resolved to approve the recommendations of the Committee for disaffiliation of Rishi College of Education, **Bairagidua**, **R.R.Dist.** (College code : 2499) from the academic year 2018-19 and to transfer the existing students in II & IV Semester to other colleges to continue their further studies.

Subsequently, the recommendation of the Standing Committee of the Academic Senate, the report of the Inspection Committee, Show Cause Notice issued to the Management of Rishi College of Education and the explanation submitted by the College Management and all other relevant documents were placed before the Executive Council for its consideration. The Executive Council in its 149th meeting held on 20-06-2018 after careful perusal of all relevant documents, resolved to approve the recommendations of the Standing Committee for disaffiliation of Rishi College of Education, Bairagiguda, R.R.Dist. (College Code : 2499) from the academic year 2018-19 and to transfer the existing students to other colleges to continue their further studies.

In view of the above decision of the Executive Council, Rishi College of Education, Bairagiguda, R.R.Dist. (College Code : 2499) is hereby disaffiliated to offer B.Ed Course from the academic year 2018-19.
