ensure compliance well before the due date as informed by the Chairman, AICTE, New

Therefore, your college, if it is falling under G.O. Ms. No. 111, M.A., dt.
08.03.1996, BHOODAN/URBAN Land Surplus Land and rest others, shall not be
granted Extension of Approval by AICTE from the academic year 2020-2021, unless the
land related documents are regularized, i.e., modification and amendments of Master
plan, Building regularization etc.

Land Surplus Land and rest others are hereby informed to take necessary action for
regularization of land related documents / building plans from the competent authorities
