He has authored a book entitled *"Broadcasters' Rights in the Digital Era: Copyright Concerns on Live Streaming"* (2020) on the applicability of copyright law on the live streaming of 'entertainment content' published by Brill-Nijhoff. He has contributed several articles on IPR in SCOPUS indexed and UGC-CARE list journals including Journal of Intellectual Property Rights. He has also delivered lectures as resource person and presented papers in several national and international seminars.
