About Osmania University:

Osmania University stands as a landmark institution in India's educational narrative. It pioneered the use of Urdu as a medium of instruction and was instrumental in shaping the economic, political, and social fabric of Telangana during the Indian independence movement.

Throughout its history, Osmania University has been a hub of educational innovation, continuously adapting to societal needs. It has nurtured and produced a remarkable array of distinguished individuals who have made significant contributions across various fields. Notable alumni include Dr. C. Narayana Reddy, a Jnanpith Award-winning poet; Suri Bhagavantham, recognized globally for his work in Physics; and Ch. Hanumantha Rao, who influenced India's economic policies.

Beyond its academic prowess, the university actively participated in both the Indian independence movement and the Telangana movement, showcasing its profound commitment to national and regional development. Osmania University continues to be a vital source of scholars and intellectuals, consistently contributing to society.

About College:

The Arts College of Osmania University began its journey on 28th August, 1919, operating out of rented buildings in Gunfoundry with a modest initial enrollment. Sir Ross Masood served as its first Principal.

Recognizing the need for expansion, a large tract of land was acquired in Adikmet in 1928. To envision the new campus, a team of experts, including Syed Ali Raza and Nawab Zain Yar Jung, embarked on an international tour. They collaborated with Monsieur Jasper, a Belgian architect, who drafted the detailed plans for the iconic buildings. After Jasper's departure in 1931, Nawab Zain Yar Jung oversaw the execution of these plans.

H.E.H. Nizam VII laid the foundation stone for the Arts College building on July 5, 1934, officially opening it on December 4, 1939. This magnificent structure, crafted from pink granite, beautifully combines the pillar and lintel style of Ajanta and Ellora with Indo-Saracenic arches, making it a significant heritage site in Hyderabad.

Initially, the Arts College building housed various university offices, including the Vice-Chancellor and Registrar, as well as the University Library, colleges of Law and Commerce. These departments were eventually moved to their own dedicated spaces. In 1973, The college transitioned to an exclusive post graduate institution for Arts and Social Sciences, discontinuing undergraduate courses. It was subsequently renamed as University College of Arts and Social Sciences, focusing on offering Post Graduate and Research courses in the field of Arts and Social Sciences.
