Sub: Osmania University – Interim Relief – Pending Revision of Scales of Pay Extension of Interim Relief benefit to the Non-Teaching Staff of the University – Orders – Issued.

Through the G.O. 1st cited above, the Government of Andhra Pradesh have sanctioned Interim Relief pending recommendations of the PRC to all Government Employees including the employees of Local Bodies (PR and ULBs) and the Government Institutions receiving Grants-in-Aid from the Government, Work Charged Employees and Full-Time Contingent Employees who are currently drawing pay in the Revised Scale of Pay 2010, with effect from 01-01-2014 @ 27% of the Basic Pay, as defined under FR 9 (21) (a)(i).

- 2. The Government vide Letter 3rd cited, while forwarding the UO Note 2nd cited, requested to send the proposal for further action to sanction Interim Relief keeping in view of certain Guidelines.
- 3. Accordingly, the proposal has been sent to the Government (Ref.4th cited), with a request to sanction additional funds for payment of Interim Relief @ 27% to the University Non-Teaching Employees, Time-Scale Employees and Pensioners. Reply from the Government is awaited.
- 4. Meanwhile, the Three Service Associations of the Employees Union, O.U., made representation for implementation of G.Os. 1st cited, for payment of Interim Relief to the Non-Teaching Employees and Pensioners of the University.
- 5. in view of the above, the Vice-Chancellor, after careful examination and in anticipation of approval of the Finance Committee / Executive Council, has accorded sanction for payment of Interim Relief @ 27%, in terms of G.O. 1st cited, to the Non-Teaching and Time-Scale Employees who are currently drawing pay in the Revised Scale of Pay 2010, with effect from 01-01-2014.

6. The Payment of Interim Relief will be regulated as follows:-

- i) The Interim Relief is admissible on Basic Pay as defined under FR 9 (21) (a) (i).
- ii) The arrears of Interim Relief for the month of January, 2014, will be paid later.
- iii) The Interim Relief shall be included in the salaries of Non-Teaching, Time-Scale and Work Charged Employees, from the month of February 2014, payable on or after 01-03-2014.
- iv) The Interim Relief sanctioned above shall be shown as a distinct element of remuneration, which shall be adjusted against any benefit that may accrue to the employees on account of revision of scales of pay and other allowances as a result of Government's decision on the Report of the Pay Revision Commissioner.
- v) The Interim Relief will **not be admissible** to the Employees drawing their pay in AP Revised UGC Scales 2006 and Part-Time Contingent Establishment.
- vi) The payment on account of Interim Relief involving fraction of fifty paise and above shall be rounded off to the next rupee and fraction of less than fifty paise shall be ignored.
- vii) The Interim Relief sanctioned above shall not count for computation of Dearness Allowance, House Rent Allowance, City Compensatory Allowance or any other Allowance, Encashment of leave, Pay Fixation, Pension or Gratuity etc.
- 7. The additional expenditure on the above score will be charged to the internal resources of the University, subject to recoupment on receipt of Funds from the Government later, in respect of the employees whose salaries are being paid from the Normal Budget.
- 8. The expenditure in respect of the employees whose salaries are being paid from the Schemes financed by UGC and other agencies will be met out of funds of the respective Schemes. The Dean, Development & UGC Affairs, O.U, will take necessary action to provide funds for the purpose.
- 9. Further, the expenditure in respect of Time-Scale employees, shall be met from the provision from which their salaries are being paid at present.
- 10. The Deputy Registrar (Accounts-Centralized Pay-Bills), O.U, shall include the Interim Relief in the salaries of the Non-Teaching and Time-Scale Employees from the month of **February 2014 onwards.**
- 11. The Dy.Registrar (Pre-Audit), O.U, will admit the claims accordingly.
