The Telangana State Revised UGC Scales of Pay 2016 in terms of G.O. 2<sup>nd</sup> cited, were implemented with the approval of the Executive Council at its 153<sup>rd</sup> Meeting held on 05<sup>th</sup>, July 2019 with effect from 01-01-2016 for the benefit of Teachers, Physical Education Personnel and Librarians vide ref.3<sup>rd</sup> cited.

2. Subsequently, the Government vide Memo 4<sup>th</sup> cited have communicated the rates of Dearness Allowance as applicable to Central Government Employees as per the Govt. of India orders to the Teachers, Physical Education Personnel and Librarians working in the Universities who are allowed T.S. Revised UGC Scales of Pay 2016 subject to the conditions laid down by the Govt. of India from time to time.

3. In view of the above and in continuation of University Orders 3<sup>rd</sup> cited, the Vice-Chancellor, has accorded approval for adoption of Govt. Memo 4<sup>th</sup> cited, governing the payment of D.A. to the Teachers, Physical Education Personnel and Librarians who are allowed the T.S Revised UGC Scales of Pay 2016 as detailed below:-

**A) DEARNESS ALLOWANCES:**



- i) The term "Basic Pay" in the revised pay structure means the pay fixed and drawn in the Telangana State Revised UGC Scales of Pay 2016.
- ii) The Dearness Allowance will continue to be a distinct element of remuneration and will not be treated as pay within the ambit of FR9(21).
- iii) The payment on account of Dearness Allowances involving fractions of 50 paise and above may be rounded off to the next higher rupee and the fractions of less than 50 paise may be ignored.

4. All the Principals and Heads of the Departments/Offices under the administrative control of the University are requested to ensure that these orders are brought to the notice of all the teachers including those on leave/deputation/foreign service.
