APPLICATION FOR RECOGNITION OF RESEARCH CENTRE

REQUIREMENT:

- 1) Research Centre to be part of a college with NAAC accreditation.
- 2) Necessary research infrastructure as per UGC guidelines and other regulatory agencies guidelines should be maintained.
- 3) Minimum of two (2) eligible teachers are required for recognition as supervisors. Supervisors are recognized only when teachers have a minimum of three (3) years teaching in P.G. / research experience and have a minimum of five (5) years of service left.
- 4) A teacher is only recognised as a “Supervisor” if there is a research centre in the college concerned.

Eligibility criteria for a Research Supervisor:

- Professor / Associate Professor of the college, with at least five (5) research publications in peer-reviewed or referred journals after obtaining Ph.D.
- Regular Assistant Professor of the college with a minimum of five (5) years teaching / research experience with a Ph.D. degree and at least three (3) research publications in peer-reviewed or referred journals.

Charges for recognition of Research Centre as detailed below:

1. Engineering Colleges (Autonomous) : ₹. 25,00,000/- for five (5) years
2. Engineering Colleges (Non-Autonomous) : ₹. 5,00,000/- for five (5) years
3. Private OU affiliation Degree / P.G college (Autonomous) : ₹. 5,00,000/- for five (5) years
4. Government Degree / PG colleges (Autonomous) : ₹. 50,000/- for five (5) years
