### ORDERS

Sub:- LOANS & ADVANCES - Sanction of Education Advance to the Regular and Time-Scale University Employees for the year 2025-26 - Orders - Issued.

Ref: 1. G.O.Ms.No. 39 FINANCE (HRM.IV) DEPARTMENT, Dt.15-04-2015.

2. O.U.Orders No.2005/05/2024-25/Accts/Bud-Gen., Dt.26-06-2024.

3. Letter No.50/TSA/OU/2025, Dt.09-06-2025 of the three Service Associations.

In pursuance of the G.O. 1st cited, the I/c Vice-Chancellor has accorded sanction for payment of Education Advance at the rate of ₹ 7,500/- (Rupees Seven Thousand Five hundred only) to each of the eligible Regular and Time-Scale Employees working in the University for the year 2025-26, subject to fulfillment of the following conditions: -

- i) Only those employees having at least one child pursuing studies would be eligible for this Advance. A declaration to that effect has to be obtained from all the eligible Regular and Time-Scale Employees in the enclosed Proforma (Annexure-I).
- ii) The Time-Scale Employees shall produce Surety (Annexure-II) from Two (2) Permanent Employees, before drawing the advance.
- iii) The amount would be restricted to ₹ 7,500/- (Rupees Seven Thousand Five Hundred only) irrespective of the number of children.
- iv) If both Wife and Husband are employed, only one of them will be eligible for this Advance.
- v) The employees drawing scale of pay of ₹ 42300 115270 (RPS 2020) or ₹ 28940-78910 (RPS 2015) as the case may be and below are eligible for the advance. In this connection, it is clarified that the employees holding posts, the Pay scale of which, is ₹ 42300 115270 (RPS 2020) or ₹ 28940-78910 (RPS 2015) or below, are eligible for the Education Advance, irrespective of the pay scale they are actually enjoying under Automatic Advancement Scheme.
- vi) This Advance is recoverable in Ten (10) equated monthly installments @₹750/- (Rupees Seven Hundred and Fifty only), per month, commencing from the salary of August, 2025 payable on or after 01-09-2025.
- 2. The expenditure on payment of Education Advance to the employees drawing their salaries from the Normal Budget will be met out of the provision made in the University Budget, for the year 2025-26, under the head "Educational Loan" (Code 603-00-02-442).

- 3. The expenditure on payment of Education Advance to Time-Scale Employees will be met out of the provision from which their salaries are being paid at present. While the expenditure in respect of employees working under various Schemes financed by the UGC and other Agencies will be met out of the funds of the respective Schemes / Agencies.
- 4. The Principals / Directors / Heads of Departments / Administrative Officers, will obtain the Declaration Form and Surety Form (to be submitted by the Time-Scale Employees) from the employees concerned in Annexure (I & II) and furnish the list of Regular Employees, who have opted to avail the Education Advance, in Annexure-III appended to these Orders, to the Deputy Registrar, Centralized Pay Bills, Accounts Branch, Osmania University, on or before 05-07-2025. Based on the list of eligible employees furnished by the respective Controlling Officers, the Education Advance will be claimed and credited into the Bank Accounts of the concerned employees directly, by the University Office. The Declaration Forms submitted by the employees shall be retained in the College / Department / Office, for record.
- 5. Separate claims shall be preferred in respect of Regular and Time-Scale Employees.
- 6. The Principals / Directors / Head of Departments / Administrative Officers will take necessary action and exercise caution in establishing the genuineness of the claim by looking at family profile and the documents of Schools / Colleges for drawing and disbursing the above Advance to all the eligible employees, as per the rules.
