In order to encourage the University Faculty to excel in Research and Development the University is inviting the applications for being considered for the **Vice-Chancellor's Research Award for the year-2022 for the Assessment period 1<sup>st</sup> December 2021 to 30<sup>th</sup> November 2022**. The Annual award carries a Citation, a Certificate and a Cash Prize for the Teacher Awardee.

**Eligibility Criteria:**

All the Regular Teachers who excel in Research with respect of the parameters like Paper Publications, Paper Presentation and Project work are eligible to apply in the following categories (one award in each category):

**Category I:** Faculty of Arts, Faculty of Social Sciences, Faculty of Commerce, Faculty of Management, Faculty of Law, Faculty of Education, Faculty of Oriental Languages.

**Category II:** Faculty of Engineering, Faculty of Informatics, Faculty of Technology, Faculty of Pharmacy.

**Category III:** Faculty of Sciences.

**Selection:**

An Expert Committee headed by the Dean of the concerned Faculty will scrutinize the applications according to the following criteria.

**i). Papers Published:**

1. Only the papers published as Corresponding Author in case of Engineering & Technology and Sciences and 1<sup>st</sup> Author in case of Humanities & Social Sciences will be considered.
2. Cumulative Impact Factor of each Reputed Journal (Scopus /Web of Science/SCI/ UGC Care-II / ABDC Journal / Thomson Reuters) in which the papers are published during the Assessment Period (1<sup>st</sup> December 2021 to 30<sup>th</sup> November 2022) is multiplied with 5 Marks.
  - a) Single Author : 100% Marks
  - b) Two Authors: 50% Marks each
  - c) Three Authors : 40%, 30%, 30% Marks
  - d) Four Authors and above: Divide Equally.

1. National Level: 2 Marks / Presentation
2. International Level: 5 Marks / Presentation

**iii). Research Projects:**

Research Projects sanctioned between 1<sup>st</sup> December 2021 to 30<sup>th</sup> November 2022.

1. Less than Rs. 5 Lakhs : 2 Marks
2. Above Rs. 5 Lakhs –Rs. 25 lakhs : 5 Marks
3. Rs. 25 Lakhs – Rs. 50 Lakhs : 10 Marks
4. Above Rs. 50 Lakhs : 20 Marks


