The University Grants Commission (UGC), New Delhi through its notification 6th cited, issued 4th amendment to UGC Regulations-2018 may be called the University Grants Commission (Minimum Qualification for Appointment of Teachers and other Academic Staff in Universities and Colleges and other Measures for the Maintenance of Standards in Higher Education) (4th Amendment) Regulations, 2024 (UIN:2/2024).

As per the 4th amendment the provision prescribed under Clause 6.3 in the University Grants Commission the Minimum Qualification for appointment of Teachers and other Academic Staff in Universities and Colleges and other Measures for the Maintenance of Statement in Higher Education (3rd Amendment) Regulations, 2023 shall substitute with the following:

“The criteria for promotions under Career Advancement Scheme laid down under these Regulations shall be effective from the date of notification of these Regulations. **However, to avoid hardship to those faculty members who have already qualified or are likely to qualify till 31st December 2024** as per the UGC Regulations on Minimum Qualifications for Appointment of Teachers and other Academic staff in Universities and Colleges and other Measures for the Maintenance of Standards in Higher Education, 2010, **a choice may be given to them either for**

being considered for promotions under the 2010 or 2018 Regulations. The date of eligibility shall be retained as the date of promotion. On the date of submission of the application, the candidate should fulfil all eligibility criteria required for promotion.”

The above amendment was placed before the Executive Council at its 181st meeting held on 03.01.2025 and the Executive Council has resolved as under:

“Resolved to implement the University Grants Commission Minimum Qualification for appointment of Teachers and other Academic Staff in Universities and Colleges and other Measures for the Maintenance of Standards in Higher Education (4th Amendment) Regulations, 2024 in Osmania University, be approved.”

In view of the resolution of the Executive Council, the Vice-Chancellor has accorded approval for implementation of the above UGC 4th amendment, dated 07.06.2024 in toto.

Consequent to the above, the Clause 6.3 of the UGC 3rd amendment Regulations, 2023 adopted vide reference 6th cited stands deleted.
