- According to the Week Hansa 2018 OU is ranked as 5<sup>th</sup> best multi-disciplinary Universities of India and 1<sup>st</sup> best State University in the country.
- Secured 5<sup>th</sup> among the Indian Universities as per India Today Survey.

#### UNIVERSITY AUTONOMY:

The Vice-Chancellor has stated that Osmania University is the only University in Telangana among 21 state universities in India to be granted **"Graded Autonomous"** status under Category-I by UGC. It has got this status by virtue of its A+ grade for Seven Years and CGPA score of 3.52 awarded by National Accreditation and Assessment Council.

This status will facilitate OU to undertake curricular reforms, start new courses, hire foreign faculty, enter into academic collaborations and run/open distance learning programs. The University can also set up new campuses, start own centers.

#### ENHANCEMENT OF OU BLOCK GRANT:

The Govt. of Telangana has enhanced the OU Block grant from Rs. 269.16 crores to Rs. 309.53 crores per year. The Govt. has also sanctioned additional grant of Rs. 60.00 crores towards development of infrastructure.

## INTRODUCTION OF NEW COURSES & INNOVATIVE RESEARCH PROJECTS:

- 1. The University is planning to introduce M.E. (Mining) Course during the academic year 2018-19 onwards at University College of Engineering, OU.
