Sir/Madam,

Through G.O. 1st cited, the Government of Andhra Pradesh have issued guidelines for sanction of Post-Matric scholarships and reimbursement of Tuition Fee & Special fee to eligible BC students. As per G.O.Ms.No.50, the College Managements shall not collect Tuition fee from the students belonging to BC Category who are eligible for reimbursement.

The Secretary, APSCHE vide Letter 2nd cited requested the University to issue suitable instructions to all the colleges for implementation of the G.O.Ms.No.50, without any deviation. Accordingly, vide letter 3th cited, all the Principals of the Colleges under the jurisdiction of Osmania University were requested not to collect Tuition fee from eligible students belonging to BC category for reimbursement.

The Commissioner of Technical Education, Government of Andhra Pradesh, through his letter 4th cited, requested to issue necessary instructions to all the Affiliated College Management not to insist upon the students for payment of Tuition fee who were covered under the Tuition fee reimbursement scheme.

Through Letter 5th cited, all the Principals of Colleges under the jurisdiction of Osmania University were requested not to insist upon the students for payment of Tuition fee who were covered under Tuition fee reimbursement scheme and allow them to write Examinations.

However, instances have come to the notice of the University that some of the College Managements are insisting upon payment of Tuition fee by the eligible students who are covered under Tuition fee reimbursement scheme.

In view of the above and in the light of G.O.Ms.No.50 and the Government Instructions issued from time to time, you are once again requested not to insist upon the students covered under Tuition fee reimbursement scheme for renewal and as well as fresh for payment of Tuition fee and allow them to appear for the examinations, as the Tuition fee is being sanctioned to all the students eligible for reimbursement by the Social Welfare Department.
