He has undergone various training programs on IPR with the Govt of India and was a part of many International and National conferences on IPR. He had the opportunity to visit overseas for IPR and Technology services in 2007 and 2009. Presently he is involved in building IP management portfolios for MSME'S and working on protecting several handicrafts and textile products for GI registration from Telangana, AP and Tamil Nadu in India. As a member of the non-Agricultural products committee of Organization for International Geographical Indications Network (ORIGIN) he was invited to Bordeaux in 2013 to deliver a lecture on Indian GI's.
