ORDERS

Sub: Osmania University – Interim Relief – Pending Revision of Scales of Pay – Extension of Interim Relief benefit to the Non-Teaching Staff of the University – Orders – Issued.

Ref: G.O.Ms.No.133, Finance (HRM.IV) Department, Dt.02-10-2023.

Through the reference cited, the Government of Telangana has sanctioned Interim Relief @ 5% of the basic pay, pending submission of report by the Pay Revision Commission, to all State Government Employees and Pensioners, including the employees of Local Bodies (PR and ULBs) and the Government Institutions receiving Grants-in-Aid from the Government, and Work Charged Employees, who are currently drawing pay in the **Revised Scale of Pay 2020**.

2. In view of the representations of Three Service Associations for payment of Interim Relief on the instructions of the Vice-Chancellor the matter was placed before Finance Committee / Executive Council for consideration for payment of Interim Relief benefit to the Non-Teaching staff / Pensioners and Work-Charged employees of the University.

3. In the 10th Finance Committee and 177th Executive Council Meeting held on 20th October, 2023, approval was accorded for payment of **Interim Relief** to the Non-Teaching staff / Pensioners and Work-Charged employees of the University at the rates indicated at para (1) above, in terms of G.O. cited.

4. The Payment of Interim Relief will be regulated as follows:-

- a) Interim Relief will be paid at the rate of Five percent (**05%**) of the basic pay / basic pension w.e.f. **1st October, 2023**. The Interim Relief is admissible on Basic Pay as defined under FR 9(21)(a)(i).
- b) The Interim Relief sanctioned above shall be shown as a distinct element of remuneration which shall be adjusted against any benefit that may accrue to the employees/pensioners on account of revision of scales of pay and other allowances as a result of the Government's decision on the Report of the Pay Revision Commission.
- c) The Interim Relief shall be applicable to all Government Employees / Pensioners, including the Employees of the Local Bodies (PR and ULBs) and **the Government institutions receiving Grants-in-Aid** and Work Charged Employees who are currently drawing pay in the Revised Pay Scales, 2020.
- d) The Interim Relief will not be admissible to the Officers of the Telangana State Higher Judicial Service, the Telangana State Judicial Service, All India Service Officers (AIS) and those drawing salaries / Pensions in UGC / AICTE / ICAR / Government of India Pay Scales, contract staff, and staff of Societies, Autonomous Institutions, Public Sector Undertakings and all those not covered under categories mentioned at 'c' above.

- e) The Payment on account of Interim Relief involving fractions of fifty paise and above shall be rounded off on the next rupee and a fraction of less than fifty paise shall be ignored.
- f) The Interim Relief sanctioned above shall not count for computation of Dearness Allowance, House Rent Allowance, City Compensatory Allowance or any other Allowances, Encashment of leave, Pay Fixation, Pension or Gratuity, etc.
5. The additional expenditure on the above score shall be charged to the University Fund i.e. **Block Grant**, in respect of the employees whose salaries are being paid from the Normal Budget.
6. The expenditure in respect of the employees whose salaries are being paid from the Schemes financed by UGC and other agencies will be met out of funds of the respective Schemes, subject to condition that they are drawing their existing salaries in RSP 2020. The Dean, Development & UGC Affairs, O.U., will take necessary action to provide funds for the purpose.
7. The Deputy Registrar (Accounts-Centralized Pay-Bills / Pre-Audit), O.U., shall prefer the Interim Relief claims of Non-Teaching Employees and credit the amounts into the respective Bank Accounts of the concerned employees directly.
8. The Deputy Registrar (Pre-Audit), O.U, will admit the claims accordingly.
