- i. Each candidate is entitled to apply only one Research proposal on any of the proposed themes.
- ii. Proposals will be evaluated through Expert Panel/Evaluation Committee members of MJPRC, OU, whose decision is final.
- iii. The research fellow, pertaining to accepted proposals, should execute a specified bond with the Director, MJPRC, OU.
- iv. Once the research proposal is selected under this scheme, after execution of the bond, an initial grant of Rs. 10,000/- will be released in the researcher's name.
- v. A Research Progress Seminar should be given in the presence of Expert Panel members on or before 45 days from executing the bond with the Director, MJPRC.
- vi. The remaining grant will be released after successfully submitting the final Research Report/Paper.
- vii. The MJPRC's Expert Panel decision shall be final in all matters related to Research Proposals.
