C I R C U L A R

Sub: University Teachers – UGC RSP 2016 – Career Advancement Scheme (CAS) – Applications called for Exercising Option for New UGC Regulations – 2018 – Circular issued.

Through the circulars under reference 1st and 2nd cited above, applications were called for from the internal eligible teachers for up-gradation/promotion under CAS of UGC RSP 2006. Accordingly certain eligible teachers of the University have applied for up-gradation/promotion.

Meanwhile the University Grants Commission (UGC), New Delhi through its notification under reference 3rd cited issued "UGC Regulations on minimum qualifications for appointment of teachers and other academic staff in Universities and Colleges and measures for the maintenance of standards in Higher Education, 2018" and the Government of Telangana through its G.O. under reference 4th cited have adopted these regulations for implementation in the Universities of Telangana State. Subsequently, the University vide its Orders No. MR-102/43/2019/Adm.II-1, dated 13.08.2019, with approval of the Executive Council in its meeting held on 23.07.2019, has adopted the G.O. under reference 4th cited in toto on revised UGC regulations, including those on Career Advancement Scheme.

Further, one of the conditions for up-gradation/promotion, as contained in para 2.8 of part-II of the Annexure to the G.O. 4th cited, reads as follows.

"The criteria for promotions under Career Advancement Scheme laid down under these Regulations shall be effective from the date of notification of these Regulations. However, to avoid hardship to those faculty members who have already qualified or are likely to qualify shortly under the existing Regulations, a choice may be given to them, for being considered for promotion under existing Regulations. This option can be exercised only within three years from the date of notification of these Regulations."

In view of the above, applications in the prescribed proforma (in duplicate) are invited from internal eligible teachers who fulfill the eligibility conditions as on 31.08.2019 as per CAS guidelines of UGC RSP 2016 or UGC RSP 2006 for movement to next higher levels, which are as under:

- a) Assistant Professor (Senior Scale) Academic Level – 11 in the Pay Band of Rs.68,900-2,05,500/-, UGC RSP-2016
[corresponding to Assistant Professor with AGP Rs. 7000/- in the Pay Band of Rs. 15600-39100 UGC RSP- 2006]

- b) Assistant Professor (Selection Grade) Academic Level-12 in the Pay Band of Rs.79,800-2,11,500/- UGC RSP-2016
[Corresponding to Assistant Professor with AGP Rs. 8000/- in the Pay Band of Rs. 15600-39100 UGC RSP- 2006]
- c) Associate Professor - Academic Level – 13A
d) Professor - Academic Level – 14
e) Senior Professor - Academic Level – 15

All the eligible teachers are advised to note the following:

- i. The teachers who have already applied in response to the University circulars 1st & 2nd cited and wish to remain for movement to next higher level under UGC RSP 2006 need not apply again. Such teachers need to submit their option to go with UGC RSP 2006 guidelines for their up-gradation/promotion under CAS.
- ii. In case, if any teacher fails to submit the option as mentioned above, it will be presumed that the teacher is willing for up-gradation/ promotion under UGC RSP-2006.
- iii. The teachers who have already applied in response to the University circulars 1st & 2nd cited and wish to opt for movement to next higher level under UGC RSP 2016 need to apply again.
- iv. The teachers who will become eligible for movement to next higher grade as on 31.08.2019 can apply either as per UGC RSP 2006 guidelines or as per UGC RSP 2016 guidelines, in view of the above rule position.

The CAS application of UGC RSP-2006 and UGC RSP-2016 along with required enclosures can be downloaded from the University website, www.osmania.ac.in.

The filled in applications in the prescribed proforma (in duplicate), along with a demand draft for Rs.600/- drawn in favour of the Registrar, Osmania University should reach the undersigned on or before 06.09.2019.

All the Principals of the University Campus and Constituent Colleges and Heads of the Departments are requested to bring it to the notice of all the teachers. Incomplete applications and applications received after the last date will not be entertained.
